Boulder Creek Fire Protection District Minutes of Board of Directors Meeting March 14, 2017

1.0 Convene Meeting/Roll Call

The regular meeting of the Board of Directors of the Boulder Creek Fire Protection District was called to order by Chairman Rogers at the Boulder Creek Fire District Office on Tuesday, February 14, 2017 at 9:02 a.m. Present were Chairman Rogers, Director Currier, Director Presswood, Director Robustelli, Director Locatelli, Chief McClish, and Secretary Vickers.

2.0 Additions and Deletions to Agenda: Chief McClish asked to add under new business, Resolution 17-06 Designation of Applicant Agent. Dir. Presswood moved to add it, Dir. Robustelli second, vote was unanimous.

4.0 Approval of Minutes of Regular Board Meeting February 10th, 2017 and minutes from the Special Board Meeting February 21, 2017.
Motion made by Dir. Robustelli and seconded by Dir. Presswood to approve minutes of February 10th and 21st, 2017 as presented. The vote was unanimous.

Chief received information from international that the chassis meets current Federal and State emissions standards. Monterey Bay Air Pollution Control District responded that they were not responsible for motorized vehicles. Board would like to move forward with Chief building a type 3 engine that would be compliant with California air standards. Motion for Chief to spec a Type 3 engine made by Dir.
