Board of Directors Minutes of the Board of Directors Meeting Regular Meeting October 11, 2022

- 1.0 Convene Meeting/Roll Call
 - The Regular Board meeting of the Board of Directors of the Boulder Creek Fire Protection
 District was called to order by Chairman Rogers on October 11, 2022 at 9:00 A.M. Present
 were Director Currier, Director Locatelli, Director Rogers, Director Robustelli, Director
 Presswood, Fire Chief Bingham, and admin Aileigh McCormack. Three Public Members
 were present. Chuck Wise, Dave Scruggs and Bruce Holloway.
- 2.0 Additions and Deletions to Agenda:
 - None
- 3.0 Oral Communications:
 - Santa Cruz County Civil Grand Jury issued a report to BCPFD called "Ready, Aim, Fire" and is investigating the actions that took place.
 - Chief Bingham will gather the information requested by the Civil Grand Jury and bring it back to the board.
 - The Board wants to see Measure N expenditures listed out clearly.
 - We cannot pull specifics on expenditures on Measure N, but we have reached out to the county to hopefully gain access to this.
 - Locatelli wants to be transparents with the public about where exactly the money is going. If it goes into an engine, he wants to see that explained out on the Measure N expenditure sheet. Board wants a timeline on getting this figured out.
 - Chief will give an update on Measure N expenditures in the November board meeting.
 - Bruce Holloway is requesting to receive packets ahead of time of meetings in the future.

.01 NFIRS Reports

• We have seen a slight increase overall with participation.

.02 Remodel of the Fire Station kitchen

- The BCFD Inc. should have input with the remodel as well since the kitchen is a main focal point for all and used heavily during fundraisers
- We will start with Junior Cortinas doing a CAD drawing for the kitchen.

.03 Generator and Fuel Tank Replacement

- Donlee Pump Company proposed an amount of \$96,724.00 for removal and replacement of 500 gallons for gasoline and 1,500 gallons for diesel.
- Fire Guard says their availability is about 10 weeks out.
- The vendor should be in contact with the county, not Chief for inspections.
- Board wants to move forward with this and get it fixed as soon as possible because of the contamination within the current pumps.
- Motion made by Dir. Locatelli to approve the forward movement on Donlee Pump Company Fire Guard Replacement, seconded by Dir. Currier. Vote was unanimous. Motion carries.
- Chief is to ask if we can skip the deposit and pay when something is delivered or completed.

.04 Resolution to adopt updated policy P-001 Part Time Maintenance Worker

- No changes made to this policy. Only updated the name and date.
- Board does not want to do individual Resolutions to adopt individual updated policies.
- Make one Resolution to approve specific policies at once. And cataloged into one document
- The Board wants to upload policies onto the website so the public has access to them.

8.0 New Business

.01 Resolution 22-09

- Denies Chief of overtime for the CZU Fire.
- Dir. Rogers will send the original document so Aileigh can change the format to match our Resolutions, update dates and overall cleanup.
- Motion made by Dir. Robustelli to adopt Resolutions 22-07, seconded by Dir. Currier. Vote was unanimous. Motion carries.

.02 Resolution 22-10

- Establishes a restricted account to place the funds into at the County.
- Motion made by Dir. Locatelli to adopt Resolutions 22-08, seconded by Dir. Currier. Vote was unanimous. Motion carries.

.03 Resolution 22-11

- Move those funds from 34400 to 34200 a restricted account at the County.
- Motion made by Dir. Presswood to adopt Resolutions 22-09, seconded by Dir. Locatelli. Vote was unanimous. Motion carries.

.04 Review of the equipment replacement schedule and replacement of the Water Tender

• Supply issues are pushing us out about 900 days for replacement of the Water Tender.

- Committee of Chief, Robustelli and Locatelli to move forward with this and work together.
- First step is to set a date to meet and begin the discussion of purchasing a new Water Tender.
- Update the document provided by Chief and then create a new Equipment Replacement spreadsheet that is easier to read and understand.

.05 District Website and Transparency SB 929

- LAFCO provided a list for items that need to be updated on the website.
- Step one is to assess and see what we are lacking. We may need to seek outside help.
- We have reached out to Dan Dawson, our website host to potentially help us with some of the issues.
- Dir. Rogers suggested a vendor called Civics Plus.
- Dir. Rogers brought up setting up a mailing list through our website so we can easily mail out agendas to the public.
- Bruce Holloway thinks we should update the links to budget, state controller and lafco before we assess the website.
- Bruce Holloway says the 2021 State Controller Form is not compliant- will look into this.
